#### OLD SPEEDWAY TREES PLANTED

Funding from the Australian Governments National Landcare Program's 20 Million Trees program was used to rehabilitate the old speedway (behind the show grounds) to native vegetation. Seedlings were planted on the 27 July by Bill Riley, Mitch Lox, Jamaine Weasel and Tim Michael, organised by the Kojonup Aboriginal Corporation. They are pictured below battling the very clayey conditions to plant over 2000 seedlings.



The 20 Million Trees Program is part of the national stream of the National Landcare Program, and has four strategic objectives:

- 20 million trees 20 million trees and associated understorey planted by 2020.
- Environmental conservation support local environmental automes by improving the extent, connectivity and condition of native vegetation that supports native species
- Community engagement work cooperatively with the community
- Carbon reduction contribute to Australia reducing its greenhouse gas emissions.

#### 12.2 SHIRE OF KOJONUP UNIQUE FLORA AND FAUNA DATASET

From the Natural Resource Management Committee minutes dated 22 February 2018:

Members of the Natural Resource Management Committee recognise that the Shire of Kojonup has many rare and endangered species of flora and fauna in reserves and along roadsides. The location of these species is not largely known, which makes prioritisation for management works difficult.

Jane Kowald will discuss this matter with local flora enthusiast, Chris Lewis to see if she has any ideas about establishing a Flora and Fauna Asset Dataset. It is not envisaged that this dataset would be widely distributed as the areas identified would be sensitive in nature.

Ms Kowald has indicated to the Natural Resource Management Advisory Committee that this has not progressed.

#### **CEO Comment:**

Please refer to recent correspondence from the Hon. Minister for Tourism, Paul Papalia regarding clearing of vegetation within roadside verges. Clearing for the sake of clearing is not supported by the Shire of Kojonup and any application is subject to prior approval of the Department of Biodiversity, Conservation and Attractions.

Council management and staff attended a roadside vegetation workshop presented by Nick Casson from the Department at the Kojonup Sports Complex on 6 June 2018.

The Roadside Conservation Committee is appointed by the Minister for Environment and is seeking to assist Local Governments to ".. promote the conservation and effective management of rail and roadside vegetation...".

- 1) Roadside values in broad context (RCC);
- 2) Regulation (DWER);
- 3) Management and maintenance (RCC); and
- 4) Threatened Flora and Communities/ESAs (DBCA).

#### Natural Resource Management Advisory Committee Comment:

The Landcare Officer has recently gained datasets from Nick Casson of the Roadside Conservation mapping and from the Department of Biodiversity, Conservation and Attractions of Declared Rare Flora in the Shire of Kojonup. Ms Kowald will commence discussions with Craig McVee and Stephanie Waldron about how to put them into a usable format and if a Procedure/Policy would be required for roadside works.

It has come to my attention that a number of Local Governments are clearing the State's valuable wildflowers from roadside verges.

Western Australia (WA) has a long-standing reputation as the Wildflower State - home to more than 12,000 species, over 60 per cent of which are found nowhere else in the world. Each year they provide a spectacle of colour, diversity and scent that needs to be experienced to be believed.

The annual wildflower season ranks as one of WA's most fascinating and precious natural treasures, attracting thousands of tourists each year. Many visitors spend time travelling our highways and other roads in search of them.

Wildflowers are also a major drawcard for Japanese visitors and with the McGowan Government currently in discussions with Japanese airlines to secure direct air services between Tokyo and Perth, it is important that we retain this key attraction in its natural habitat along roadsides.

I seek your assistance in ensuring that wildflowers are not destroyed or fragmented in drive corridors to encourage tourism to regional areas and towns within your jurisdiction.
