#### 11 STATUS REPORTS

#### 11.1 NRM/LANDCARE OFFICER REPORT – STATE NRM COMMUNITY ACTION GRANTS A16046

The project is currently on track with 35,000 seedlings in the ground and 3.7km of fencing erected. There is some difference between the actual spend and grant allocation so we are currently negotiating a project variation to put in some more seedlings and fences this season.

#### 11.2 KEEP AUSTRLIA BEAUTIFUL COMMUNITY LITTER GRANT 'BACK TO THE TAP' - CLG2018-14

The 'Meet PAT' water bottle refill station was installed at Apex Park during May. The next edition of the Shire of Kojonup's E News and local Kojonup News will feature an article about it. After it has been published, the acquittal forms can be submitted.

#### Attachment 11.4.1 – Pest Plants Local Law – 2014 WALGA Template

The NRM/Landcare Officer, Jane Kowald, tried several times to contact the Department of Primary Industries and Regional Development, with a view to get someone to address the Shire Councillors at a meeting. I received no response to my enquiries and will attempt again.

In regards to committee decision:

- 24/18 Moved: Kath Mathwin Seconded: John Benn
  That the Natural Resource Management Advisory Committee recommends to Council
  that a Local Law is developed to eradicate the following species from the Shire:
  - 1. Pattersons Curse (Echium plantagineum);
  - 2. Black Wattle (Acacia decurrens);
  - 3. Golden Wattle (Acacia pycantha); and
  - 4. Flinders Range Wattle (Acacia iteaphylla).

A template for a Pest Plants local law is attached for your reference.

After extensive discussions with both Anthony Middleton, Manager of Corporate and Community Services, Judy Stewart, Senior Administration Officer and James McGovern, Manager Governance WALGA, the following was pointed out as points to discuss before putting forward the proposal to adopt the local law.

1. The Department of Primary Industries and Regional Development advise that Local Government authorities can prescribe problematic plant species as 'pest plants' under the *Biosecurity and Agriculture Management Act 2007* (BAM Act). This can be applied to any plant that, in the local government authority's opinion, is likely to adversely

affect the environment of the district, the value of property in the district, or the health, comfort or convenience of the district's inhabitant. Under section 193 of the <u>BAM Act</u>, local government authorities (local authorities) can prescribe any plant, other than a declared plant, to be a 'pest plant'.

- 2. Local Governments generally adopt a Pest Plant Local Law as part of a broad education and information approach to the control of a particular pest or pests. Local Laws are therefore used a means to provoke action on private property, rather than as a formal mechanism of enforcement.
- 3. At VROC level, it was strongly felt that pest plants were a State Government issue and should be controlled through the BAM Act.
- 4. If you did make it a Local Law, how do you police it and where do the required resources come from?
- 5. The Shire of Kojonup is responsible for roadsides that some of these weeds are currently growing on, should they all be removed first? How much will that cost? Where will the resources come from?

It was resolved that the NRM/Landcare Officer still pursue this agenda item.

#### 11.4 WEEDING WATTLES BUSY BEES

Commencing once again on Wednesday, 5 June 2019, focusing on the area north of the old rubbish tip site where past revegetation activities have taken place.

#### 11.5 FOREST PRODUCTS COMMISSION COMMUNITY SUPPORT PROGRAM

A grant has been secured to hold events at the Myrtle Benn Flora and Fauna Sanctuary celebrating World Environment Day (Wednesday 5 June 2019). Activities will involve bug hunting with magnifying glasses and bird watching with binoculars purchased as part of the grant.

77 children from St Bernard's Catholic Primary School will participate on the 17 June and 24 students from Years 1 and 2 from Kojonup District High School will participate on the 19 June. Volunteers with Working with Children Checks are welcome to assist on those dates.

#### 11.6 PLANET ARK SCHOOLS TREE PLANTING DAY FRIDAY 26 JULY 2019

This event will be taking place at the Old Rubbish Tip site on Robinson Road. Preparation has begun with knockdown sprays planned and 4,500 seedlings ordered. Volunteers to help on the day would be appreciated.

#### 11.7 RESERVE MANAGEMENT PLANS

The Corporate Business Plan - 'SMART' Implementation, reference 1.2.6 (page 12) states that Works and Services will "develop environmental management plans for significant Shire reserves", which should be completed in 2020/2021.

Jane Kowald and Marina Murray are working to progress this with the idea of producing an overarching document briefly describing all reserves in the Shire. High value reserves will be identified as part of this process and it will be recommended that these reserves have an individual environmental management plan written for them by an appropriate consultant.

Noted that exhausted gravel pit reserves should be listed in this plan with the suggestion to change the classification to 'recreation' or 'flora and fauna'.

#### 11.8 USING LOW RATES OF CHEMICAL IN RESERVES FOR WEED MANAGEMENT

At the Reserve Management Forum held by the Shire of Kojonup in 2017, John Moore, Department of Agriculture and Food, gave a presentation on the effect of herbicides on natives, from which the roadside misting idea has sprung which has been much discussed by the Natural Resource Management Advisory Committee.

Jane Kowald, Marina Murray, Mark Swinfield and Latasha Hira have been working together to extend this idea to be used in reserves of low biodiversity value and high weed burden. A demonstration will be conducted in the bush area opposite the cemetery along Tunney Road.

This patch of bush was chosen as it has a high density of freesia bulb weeds growing as well as a variety of grasses and tagasaste. Treatments that will be included in the demonstration are as follows:

- 1. 0.1g/10L Metsulphuron
- 2. 0.5g/10L Metsulphuron
- 3. 250mL/100L Glyphosate
- 4. 500mL/100L Glyphosate
- 5. 750mL/100L Glyphosate

Treatment plots are being pegged and photo monitoring as well as a detailed vegetation assessment will be carried out before spraying commences.

#### ATTACHMENT 11.8.1 - I ICR30653 – STATE NRM BLACK COCKATOO PROJECT PROPOSAL

#### Dear Jane

SWCC has been developing a collaborative project for submission in the current round of State NRM Community Stewardship Grants. The aim of the project is to determine if it is possible to use the foraging behaviour of forest red tailed black cockatoos (FRTBC) to select marri trees for improved growth rates, disease resistance and seed production. FRTBCs have been shown to selectively feed on marri trees that produce a greater number of heavier seeds per fruit than trees that the birds do not feed from. Using this relationship we plan to enlist the help of citizen scientists across the range of the SW black cockatoo species to submit data on the locations of trees, primarily marri, that the cockatoos feed from. (In the process we also hope to gain valuable data on the location of feeding sites for Baudin's and Carnaby's cockatoos to aid in their management). Using the data collected from citizen scientists we will collect seeds from ~30 sites from feed and non-feed trees and then grow out this seed in landcare nurseries across the species range, in the process collecting data on the germination, survival and growth rates of the two lines of seed. The seedlings from this project will be provided free of charge to revegetation projects on the condition that each seedling is planted with an identification tag and access is provided for the exact GPS location of each planted seedling to be recorded. This location data will be used in future to assess whether then trees grown from these seedlings produce fruits and seeds that FRTBCs will feed from.

This project spans the entire range of black cockatoos in the SW of WA extending from Mundaring to Albany and as such involves a large number of partner organisations. We are hoping to have 14 local community landcare groups involved, delivery 21 community engagement events at the start and end of the project as well as participating in seed collection activities. Seed will be grown out at nurseries in Denmark, Bridgetown, Bunbury, Oakford and Hazelmere with local groups in those areas contracted to undertake monitoring and data collection activities. We are hoping to secure planting locations across the span of the black cockatoo's range also and will engage local NRM groups to undertake the task of recording the locations of planted seedlings. In all this will results in over \$190,000 in funding being distributed to community NRM groups.

We would like to include the Shire of Kojonup as a project partner in this grant to deliver the following parts of the project:

Coordinate community engagement event – July-October 2020 – in partnership with Birdlife WA to promote the citizen science app and to train potential citizen scientists in how to distinguish between the different black cockatoo species and their feeding signs.

- In Kojonup
- Includes, event coordination, promotion, venue hire, catering and running event
- Funding \$2,200 per event

#### Seed collection - Sep-Oct 2021

- Attend seed collection training day -1 project officer \$440 plus travel @\$0.68/km
- Seed collection to be paid at \$550 per day plus travel @\$0.68/km

#### Seed germination, survival and growth rate assessment of ~450 seedlings

- Germination rate assessment at 1 month post planting, survival and growth rate (seedling height) assessment at 3 and 6 months
- Germination assessment ~ 3 days work \$1650 November/December 2021
- Survival and growth rate assessment ~3 days work \$1650 each for 2 assessments in Jan/Feb and May/June 2020

#### GPS recording of seedling locations (SWCC to provide differentiated GPS system) - June-August 2022

- \$55 per hour at a rate of 30 plants per hour, payment dependent on number of seedlings per site.
- Travel to/between sites \$0.68/km

**Coordinate community engagement event - September-November 2021** – in partnership with Birdlife WA and SWCC to present project outcomes and findings to the community.

- In Kojonup
- Includes, event coordination, promotion, venue hire, catering and running event
- Funding \$2,200 per event

If you would like to join as a project partner we will require a letter of commitment from your organisation to deliver the above aspects of the project and the statement of in-kind contribution through the provision of office space, workers compensation/public liability insurance etc. for the staff member who will undertake the contracted tasks.
