To whom it may concern

I would like to make comments regarding the proposed Wind Farm near Kojonup. While I believe that wind power may in the future be quite important, I truly do not believe that land owners should be subjected to them within 2kms of their homes. I for one would be greatly opposed to having wind turbines within 800 metres of my home, and until research is done properly – I do not feel that anybody has the right to subject home owners to them without knowing fully what the health implications are, or the implications to the property value.

If property value decreases, then surely the Shire would have to adjust the rates accordingly, very similar to if farmers are constricted in their farming practices because of the GM and non-GM issue, I for one would not like to pay our rates at the higher rate if the land value is down. As yet, no one will know the full implications of farmers trying to sell and if wind turbines will affect how quickly they sell.

I would like to see our Shire take into consideration to move a recommendation that wind turbines be situated at least 2kms from a dwelling, regardless of who owns that dwelling. Also, the Shire needs to consider the whole of the community, not just a small minority.
